Dear Fellow Sawgrass Members,

Thanks to your continued support, our sixth year featured continued successes in providing scholarship assistance and crisis/hardship relief to our amazing Sawgrass employees and their families. In 2025 we provided \$114,026 in funding (\$23,657 more than '24) for 53 scholarships (up from 49 last year) and we were able to support four employees with hardship relief. Our scholars attended schools including UNF, JU, Florida, FCJU, Florida State, Penn. St. and St. Johns River. All of these achievements were made possible by you, our donors and supporters, who so generously give to further the impact of our mission. Thank you!

The highlights of our fundraising and awareness events in 2025 were Foundation Day (February), Sawgrass Art Show (April), Greenskeeper's Revenge (July) and our ongoing member philanthropic gifts.
